By entering this raffle, entrants accept and agree to all of the rules, limitations and restrictions set forth herein. Contest limited to the first 5,000 entrants. The odds of winning depend on the number of tickets sold and will be no greater than 1/5,000. Tickets are \$20.00 each and only one eligible person may be entered in the raffle per ticket sold. Entrants must be 18 years or older to enter. Tickets must be purchased between 7:00am (CST), Wednesday, February 22, 2017 and 11:59pm (CST), Friday, May 26, 2017.
